**DU PAGE COUNTY DRUG COURT
PLEA AGREEMENT AND CONTRACT**

In consideration for the opportunity to participate in the DuPage County Drug Court Program (DCP), the below signed defendant agrees that he or she shall:

1. Comply with all terms and conditions of the DuPage County Drug Court Program as established by the Court or the Department of Probation and Court Services.
2. Maintain a DuPage County residence as verified by Probation, or as agreed by DuPage County Drug Court Program.
3. Complete all required assessments and evaluations, and participate in and successfully complete all treatment and therapeutic groups and/or education/training groups or classes as directed by Probation.
4. Pay a portion of the cost of education/assessment/treatment as directed by Probation.
5. Submit samples of blood, urine, or breath for testing for the presence of alcohol or drugs or other prohibited substances under this contract, as directed by Probation or the Court.
6. Pay restitution, fines, costs and fees, as ordered, and not less than sixty (60) days prior to graduation.
7. Permit DuPage County Probation Officers to visit his or her residence, place(s) of employment, or other designated locations.
8. Appear on time at all subsequent court dates as set by the Court or Probation.
9. Not possess any firearms or other dangerous weapons.
10. Attend Alcoholic Anonymous, Narcotic Anonymous, and/or other support groups as directed by the Court or Probation.
11. Not use, ingest, or possess alcohol or any controlled substance.
12. Not use, ingest, or possess any non-prescription drug or any prescription drug other than that authorized by his or her therapist, psychiatrist, or other licensed medical provider.
13. Accept and complete any sanction imposed by the Court for program violations, including but not limited to, the Sheriff's Work Alternative Program (SWAP), community service, or jail.
14. Sign releases for all relevant information including drug testing, medical, and psychological/psychiatric records.
15. Agree to the permanent transfer of all DuPage County Drug Court cases to Courtroom 4003 through completion of the program or sentencing.
16. Defendant agrees to pay a probation fee of \$25.00 each month.

17. Defendant understands and agrees to the following:
 - a. If the defendant commits a violation of a felony offense, or DUI, the State may immediately file a Petition to Terminate Unsuccessfully the defendant from the Program, and may file a Petition to Revoke Bond;
 - b. If the defendant is unsuccessfully terminated from the Program for any reason, a Pre-sentence report will be ordered and the case shall proceed to sentencing.
 - c. If the defendant has an outstanding warrant issued during participation in DuPage County Drug Court which is active for more than forty-five (45) days, the defendant shall be terminated from the Program.
18. The Defendant has read and understands all of the above referenced requirements and conditions of participation in the Drug Court Program and further agrees as follows:
19. Defendant will enter a plea of guilty to the following charges:

And remain on bond, with sentencing deferred until either the completion of or unsuccessful discharge from the program.
