RESOLUTION NO. 2014-1  
A RESOLUTION OBJECTING TO ZONING PETITION Z14-034  
Ruth Lake Country Club  
DuPage County, Illinois  
Regarding Conditional Use approval of a gun club on  
a golf course in an R-4 Zoning District**

**Whereas**, the Board of the Golfview Hills Park District has become aware of the proposal of the Ruth Lake Country Club to establish a gun club within its boundaries; and

**Whereas**, the Park District is the owner of real estate proximate to the Country Club, specifically parcels identified by PIN Numbers 09-14-108-003, 09-14-108-005, 09-14-108-007, 09-14-111-002, 09-14-113-027, 09-14-117-001, 09-14-117-020, and 09-14-209-020; and

**Whereas**, the Board, upon due investigation and careful consideration, has determined that approval of the Zoning Petition would adversely affect the operations of the Park District and the constituency it serves as follows:

1. Shotgun shooting will constitute a nuisance in a heavily populated residential area; and
2. The noise pollution will destroy the quiet and serenity of the parks near the lakes. The parks and lakes are a positive attraction for the area; and
3. The noise pollution could result in hearing impairment and other health injuries to residents, especially the young and elderly, and pets within the parks established for serene reflection and enjoyment; and
4. The noise and shot pollution may injure and interfere with established wildlife, including federally protected migratory birds that overnight in our parks and land adjacent to the parks; and
5. Stray or windblown skeet shot could cause injury to individuals using our parks.

**WHEREAS**, The Board desires to inform the DuPage County Zoning Board of Appeals its objection to the proposed Zoning Petition Z-14-034 by Ruth Lake Country Club;

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE GOLFVIEW HILLS PARK DISTRICT, DUPAGE COUNTY, ILLINOIS**, as follows:

**SECTION 1:** The Board opposes the proposal for Zoning Petition Z14-034 Ruth Lake Country Club pending before The DuPage County Zoning Board of Appeals; and

**SECTION 2:** The Board directs the Secretary of the Board to forward a certified copy of the Resolution to the President of the DuPage County Board and to the Chairman of the DuPage County Zoning Board of Appeals and

**Section 3:** Suzanne Zuver, who is an elected commissioner and President of the Golfview Hills Park District and a resident of Golfview Hills is hereby appointed the agent and attorney in fact of the Golfview Hills Park District to represent, speak, and act on behalf of the Golfview Hills Park District before the DuPage County Board of Appeals, the County Development Committee, and the County Board with respect to all matters pertaining to the said Petition Z14-034

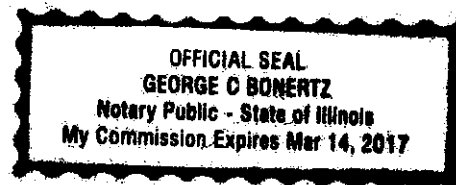
