POSITION SUMMARY

Under immediate supervision; performs work of routine difficulty assisting the Supervisor of Voting; performs related work as required.

DISTINGUISHING FEATURES OF THE CLASS

An employee in this class is responsible for the accurate and timely data entry of registration-related information. Work involves processing a high volume of records from documents that may require interpretation and clarification. This position is distinguished from other registration positions by the ability to independently research, collect and analyze data. Work is performed under the immediate direction of the Supervisor of Voting.

ESSENTIAL DUTIES AND RESPONSIBILITIES

The list of duties and responsibilities is illustrative only, and is not a comprehensive listing of all the duties and responsibilities performed by positions in this class.

- Assists the Supervisor of Voting
- Serves as secondary resource for Voting programs
- Assists in managing and developing training for voting programs
- Assists in maintaining Vote by Mail, Healthcare Facility and Permanently Disabled Voting Programs
- Assists in Provisional verification process
- Qualify voter eligibility for programs
- Assist in scheduling and training for Healthcare facility voting
- Assists in Military/Overseas Vote by Mail program
- Correspondence to inquiries regarding Vote by Mail voting
- Process Vote by Mail applications and mail ballots to voters
- Assists in coordinating the Vote by Mail verification process
- Assists in performing various research and preparing statistical voting reports
- Assists in Election production
- Maintains regular attendance and punctuality

NON-ESSENTIAL DUTIES AND RESPONSIBILITIES

- Adjusts work assignments and schedules based on election cycle to participate in election preparation.
- Adjusts work assignments and schedules in the event of an emergency to participate in emergency preparedness, response, and recovery activities as assigned.
- Depending on assignment may maintain required emergency management training, licensure and/or certifications.
- Performs related duties as required or assigned within job classification.

QUALIFICATIONS

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and /or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform essential functions.

EDUCATION and/or EXPERIENCE

Completion of a High School Diploma or General Equivalency Diploma equivalent and two (2) years of progressively responsible experience performing a variety of general office work including, data entry, analysis, customer service; or, an equivalent combination of training and experience sufficient to successfully perform the essential duties of the job such as those listed above.

PHYSICAL REQUIREMENTS

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of the job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

Exerting up to 25 pounds of force occasionally and/or a negligible amount of force frequently or constantly to lift, carry, push, pull or otherwise move objects, including the human body. Sedentary work involves sitting most of the time. Jobs are sedentary if walking and standing are required only occasionally and all other sedentary criteria are met.

WORK ENVIRONMENT
