NOTE

1. Current and prior years *DuPage County Financial Plans* are source materials utilized to obtain the tax levies and rates.
2. The 2018 Tax Levy and Rate are estimated figures from the *Fiscal Year 2019 Financial Plan*.
3. Taxes are collected in the subsequent year after levied. For example, the amount levied in 2018 is collected in 2019.
4. The levy for the Courthouse Bond Debt Service is established per bond ordinance.
5. Illinois Compiled Statute 55 ILCS 5/5-1024 allows the County Clerk to levy a 1% cost of collection factor to: a) County I.M.R.F.; b) Health Department I.M.R.F.; and, c) Courthouse Bond Debt Service. The 1% factor is not reflected in this schedule.
