With the General Primary Election nearing, I would like to let you know about how thousands of DuPage County voters have been qualified to vote in just the past few months by taking advantage of online registration.

While regular registration to vote in person at locations across the County has closed, the quickest and most convenient means is still available by using the Illinois online registration system at: <http://ova.elections.il.gov/>.

The deadline to register to vote online for the General Primary Election is March 4th.

If you wish to register in person, Illinois law enables you to register by taking advantage of "Grace Period" Registration. Registering to vote or transferring a registration during the "Grace Period," requires you to also vote at the same time.

You can take advantage of the "Grace Period" Registration at the following times and locations:

- Feb. 21st - Mar. 3rd Election Commission Office
- Mar. 5th - Mar. 19th Locations throughout DuPage

We strongly urge you to register to vote prior to the March 20, 2018, General Primary Election to avoid potentially long lines in the polling place on Election Day.
