With the Consolidated Election nearing, I would like to let you know about how thousands of DuPage County voters have been qualified to vote in just the past few months by taking advantage of online registration.

While regular registration to vote in person at locations across the County has closed, the quickest and most convenient means is still available by using the Illinois online registration system at: <http://ova.elections.il.gov/>.

The deadline to register to vote online for the Consolidated Election is March 17th at: <http://ova.elections.il.gov/>.

If you wish to register in person, Illinois law enables you to register by taking advantage of "Grace Period" Registration. Registering to vote during the "Grace Period," requires you to also vote at the same time.

You can take advantage of the "Grace Period" Registration at the following times and locations:

- Mar. 6th - Apr. 2nd Election Authority Office
- Mar. 18th - Apr. 1st Locations throughout DuPage
- April 2nd All County Polling Locations

We strongly urge you to register to vote prior to the April 2, 2019, Consolidated Election to avoid potentially long lines in the polling place on Election Day.

**Curbside Voting**—is provided to any voter who is unable to access or enter the polling place due to a disability. The voter may request curbside assistance in writing no later than 5:00 pm on Monday, April 1, 2019 to the DuPage County Clerk's Election Division at 421 N. County Farm Road, Wheaton, IL 60187. Please include the voter's name, current residential address, precinct, polling place, the hour the voter expects to arrive and if available their cell phone number.

If the voter cannot file that request in advance, the voter may still go to the polling place on Election Day, and alert the Judges of Election or call our Election Office at 630-407-5500 with the necessary information.

## Become a Student Judge of Election

Illinois Statutes provide the opportunity for high school juniors and seniors, who are not entitled to vote, to be appointed as election judges if, as of the date of the election at which the person would serve as a judge, he or she:

Is a U.S. citizen

Lives in DuPage County

Is a junior or senior in good standing enrolled in a public or private secondary school

Has a cumulative grade point average equivalent to at least 3.0 on a 4.0 scale;

Can obtain the First Judge Application and Nomination form from the Social Studies Chairman and/or Government teacher at school;

Has completed the First Judge Application and Nomination form with all signatures needed and returned to teacher, to be sent to the Election Authority;

Has satisfactorily completed the training course for judges of election; and

Meets all other qualifications for appointment and service as an election judge.

The student must be available to work from 5:00 a.m. until approximately 9:00 p.m. on Election Day.

Every effort will be made to place the student at a polling place near their home.

Students are compensated for working on Election Day.

Students appointed as election judges under this subsection shall not be counted as absent from school on the day they serve as judges.

The Election Authority firmly believes this is a worthwhile endeavor for everyone involved, and one which undoubtedly enhances the student's education in current events and justifies a one-day excused absence from class.

Cumple con todos los demás requisitos para el nombramiento y servicio como juez electoral.
