

**Resolution No. 18-90**

**A RESOLUTION PROVIDING FOR THE SUBMISSION TO THE ELECTORS OF THE VILLAGE OF VILLA PARK, DUPAGE, COUNTY, ILLINOIS, AN ADVISORY REFERENDUM OF WHETHER THE VILLAGE SHOULD FUND REPAIRS FOR THE REOPENING OF LUFKIN POOL**

**WHEREAS**, the Village of Villa Park (the “*Village*”) is a duly organized and validly existing non home-rule municipality created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State; and,

**WHEREAS**, Section 3.2-40-60 of the Illinois Municipal Code (65 ILCS 5/3.1-40-60) provides that the President and Board of Trustees (the “Corporate Authorities”) may authorize an advisory question of public policy to be placed on the ballot at the next regularly scheduled election in the municipality; and,

**WHEREAS**, Section 28-2 of the Election Code (10 ILCS 5/28-2) provides a method of submission of advisory public policy referendum and that such referendum may be initiated by the Corporate Authorities by passage of a resolution requesting the submission of the referendum for consideration by the voters of the Village; and,

**WHEREAS**, the Corporate Authorities hereby finds that it is in the best interest of the Village to submit the referendum of whether the Village should make repairs to reopen Lufkin Pool.

**NOW, THEREFORE, BE IT RESOLVED** by the President and Board of Trustees of the Village of Villa Park, DuPage County, Illinois, as follows:

Section 1: The Corporate Authorities finds that the recitals set forth above are true and correct and includes the recitals in this Resolution.

Section 2: The Corporate Authorities finds and determines that it is in the best interest of the Village to provide for an advisory referendum concerning whether repairs should be made to reopen Lufkin Pool.

Section 3: The Village Clerk is directed to immediately certify and submit the following public question to the DuPage County Election Authority and DuPage County Clerk to be placed on the ballot for the consolidated election to be held on April 2, 2019, in the following form:
